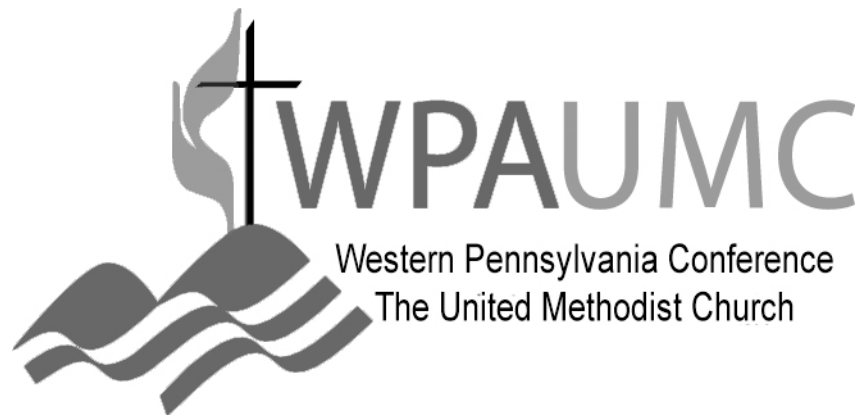
Fixes charge conference membership of all ordained ministers appointed to ministries other than the local church.
